We had floated tender on gem portal vide bid number GEM/2022/B/1907301, we had to cancel the tender due zero participation. We then researched regarding backup tapes and found that the said items are not manufactured in India and are mostly based out of Japan and China. This results in deviation from Make-In-India Preference Clause. We received mails from the probable bidders claiming that they could not bid due to MII clause. As the intended goods are not manufactured in India, we propose to proceed the purchase with non-make in India clause. |

- 1. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the year. In case of bunch bids, the primary product having highest value should meet this criterion.

### 3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. The Bidder should have executed Orders of LTO-8 Backup Tapes for value of at least **Rs.3 lakhs** during the last **03 years** (as on previous month). Bidder has to submit Purchase Order copies along with valid documents to prove the delivery of items.
- **2. For Experience Criteria** Bidder should submit the documents of its own experience . In case the bidder is OEM, then bidder can submit the documents of its own experience or its authorized partners.
- 3. The bidders must provide quotations for 100nos. Barcode Labels for the LTO8 Tapes.
