The eligibility criteria for the selection of bidders for AMC of UPS are as below:

- Should be in the business of Maintenance of UPS for the last three years.(supportive document proof to be provided)
- 2) Should have a service center at Hubli
- 3) Should have an average total turnover of atleast Rs. 1 crore per year for the last three years. (Last 3 years Annual turnover statement/ income tax return/Audited Balance sheet, certified by CA required)
- 4) Should have made net profit at least in two years out of the last 3 financial years.(Profit & Loss Account certified by CA required)
- 5) Maintain sufficient spares at their service center and also at UIIC Regional Office.

Terms and Conditions

- The vendor is required to respond promptly to any calls/mails from all our offices covered under AMC with timely service of UPS &related components.
- Preventive maintenance should be carried out once in 3 months and PM reports and call reports need to be submitted to UIIC for payment processing.
- 3) Preventive maintenance includes but not limited to filling of distilled water to batteries including those supplied by other vendors and for batteries under warranty, inspection, testing, satisfactory execution of all diagnostics, cleaning and removal of dust, and dirt from the interior of the UPS, batteries, testing and repairing of battery terminals and wires, and necessary repairing of UPS.
- 4) Unscheduled on-call corrective and remedial maintenance services to set right the malfunctions of the UPS along with stabilizers to be provided.
- 5) Exclusions in the agreement would include electrical work external to the devices covered under AMC, damage resulting from accidents, lightning, fire not originating from UPS, etc
- 6) All other repairs apart the those specifically excluded in the agreement would be covered under AMC.
- 7) Replacement of parts will be at the bidder's cost with the original spares of the brand/make of the UPS as far as possible. In the event of non-availability of parts, equivalent or higher configuration components should be substituted with the company's consent.
- 8) In case of major fault necessitating the equipment to be taken to maintenance bidder's office/factory, STANDBY equipment has to be provided at no extra cost. The cost of the transportation of any defective item for repairs shall be borne by the bidder.
- 9) For offices located at district headquarters, the bidder shall attend to on-call services within 24 hours of lodging of the complaint and further close all service calls within 48 hours. For places other than district headquarters, bidder shall attend to calls within 48 hours and close all service calls within 72 hours. These timelines are excluding holidays.
- 10) In the event the bidder is not able to close the call within the above stipulated time, a standby system should be provided failing which penalty as under would be levied as under

Rs 150/- per working day per UPS

11) In the event the bidder is not able to perform preventive maintenance in the stipulated timeframe including filling up of distilled water in batteries penalty would be levied as under.

Rs.1000/- per UPS

12) Any addition or removal or relocation of UPS during course of contract will be considered under the contract of AMC.



EMD

- a. Bidder shall have to submit EMD of ₹ 25,000/- (Rupees Twenty Five Thousand only) by Account Payee Demand Draft drawn in favor of "United India Insurance Co. Ltd" payable at hubli.
- b. Bid received without earnest money or in the form of other modes will not be entertained/considered at all and will be rejected summarily.
- c. No interest would be paid on the Earnest Money Deposit.
- d. MSME companies registered with NSIC are exempted from submission of EMD as per GOI guidelines. For exemption, bidders have to submit certificate.

Forfeiture of EMD:-The earnest money deposited (EMD) will be forfeited if the bidder withdraws or amends, impairs and derogates from the tender in any respect within the period of validity of tender. In case the successful bidder declines the contract, for whatsoever reason(s).

You may therefore arrange to send us the sealed commercial and technical proposal for each item per unit basis as per annnexure-1 and annexure-2. If you fulfill the criteria cited above, the total amount for all items put together would be taken into consideration for finalizing the L1 vendor for AMC depending upon initial requirement.

- a. Separate commercial and technical bid should be submitted.
- b. Quarterly payment may be released on closure of all pending calls and submission of service and preventive maintenance reports
- c. For finalizing the contract, technical and commercial both will be considered.
